Known as Ruchie by her friends and family, she was elected as Civil Court Judge in November 2016 and is currently assigned to Queens County Civil Court thereby becoming the first Hasidic Jewish woman to be elected as a civil court judge in New York State, and the first Hasidic woman to hold public office in United States history.

After graduating Bais Yaakov, Rachel worked as a legal secretary working her way up to paralegal while supporting her husband, who studied Torah full time during the first ten years of her marriage. She attended Brooklyn Law School part time so that she would have time to study law while raising her six children. Rachel is a proud, devoted mother and grandmother of a Chassidic Family.

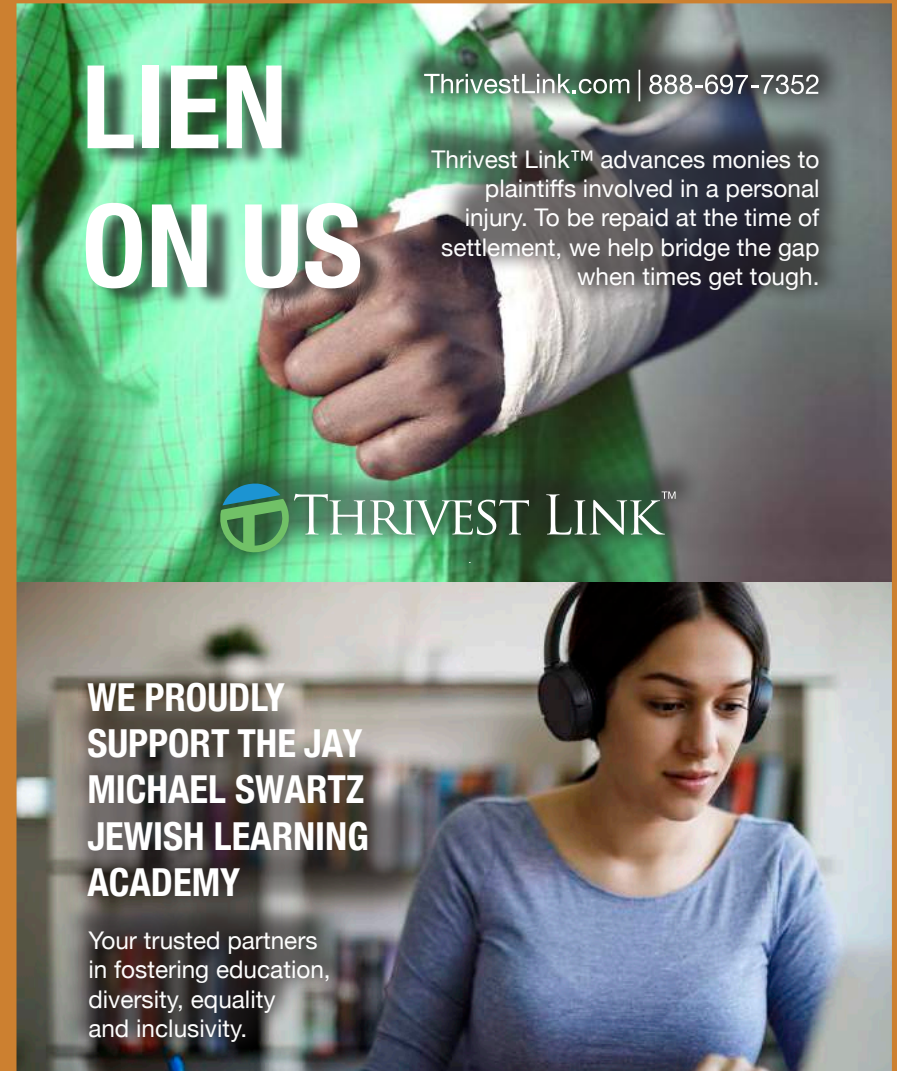


